

Gōdō Martial Arts — Terms of Use

1. About these Terms

These Terms of Use govern your use of the Gōdō Martial Arts website at **godomartialarts.co.uk** ("the Website").

By accessing or using the Website, you agree to comply with these Terms of Use.

If you do not agree with these Terms, please do not use the Website.

These Terms relate primarily to your use of the Website. Separate terms, membership conditions, club rules and safety requirements may apply to participation in Gōdō Martial Arts training, grading, events and competitions.

2. About Gōdō Martial Arts

Gōdō Martial Arts is an independent martial arts school providing instruction in **Sport Karate and Kickboxing**, together with associated training, grading and competition activities.

Information about classes, instructors, prices, venues, grading requirements and other services is provided for general information and may be updated from time to time.

We aim to ensure that information published on the Website is accurate and current. However, we cannot guarantee that every piece of information will always be complete, accurate or up to date.

3. Classes and Training

Information displayed on the Website regarding:

- training times;
- venues;
- prices;
- membership;
- grading;
- competitions;
- instructors;
- courses and events; and
- availability

is subject to change.

Training sessions may occasionally need to be changed, cancelled or relocated due to circumstances including venue availability, instructor availability, competitions, holidays, maintenance, weather or other circumstances beyond our reasonable control.

Where reasonably possible, we will provide advance notice of significant changes.

4. Free Taster Sessions

Where offered, a free first lesson or taster session is subject to availability and booking requirements.

A free taster is intended to allow prospective students to experience a Gōdō Martial Arts training session before deciding whether to join.

Participation in a taster session does not create an obligation to become a member.

We reserve the right to decline or restrict participation where reasonably necessary for safety, safeguarding, capacity or other legitimate operational reasons.

5. Prices and Payments

Current prices are displayed on the Website where applicable.

Unless otherwise stated, prices are quoted in **pounds sterling (£)**.

Our advertised prices may include:

- training/session fees;
- membership or licensing fees;
- grading fees; and
- other charges specifically identified at the time.

Additional charges will not be introduced without appropriate notice and, where required, the customer's agreement.

Nothing in these Terms affects your statutory rights concerning services supplied to consumers. Consumer services must be provided with reasonable care and skill and other statutory rights may apply.

6. Membership

Participation in regular Gōdō Martial Arts training may require membership and registration. Membership requirements, insurance arrangements, licensing, grading and other conditions may be explained separately during the joining process.

Membership does not guarantee progression to a particular grade, competition result, instructor appointment or other outcome.

Progression is based upon the individual's attendance, ability, conduct, technical development and assessment against the applicable Gōdō Martial Arts requirements.

7. Martial Arts Training and Safety

Martial arts training involves physical activity and an inherent risk of injury.

Students are expected to:

- follow reasonable instructions given by instructors;
- behave respectfully towards instructors and other students;
- use required protective equipment;
- inform an instructor of any relevant injury, illness or physical limitation that may affect participation;
- train within their own capabilities; and
- comply with Gōdō Martial Arts rules and safety procedures.

Gōdō Martial Arts reserves the right to modify or restrict an individual's participation where an instructor reasonably considers this necessary for safety.

Nothing in these Terms excludes or limits liability where doing so would be unlawful.

In particular, these Terms do not exclude liability for death or personal injury caused by negligence, fraud, or any other liability which cannot legally be excluded or limited.

8. Student Conduct

Gōdō Martial Arts is committed to maintaining a respectful, safe and inclusive training environment.

Aggressive, threatening, abusive, discriminatory or deliberately disruptive behaviour will not be tolerated.

Students may be asked to leave a training session where their behaviour presents a risk to themselves or others or seriously disrupts the class.

Serious or repeated misconduct may result in membership or training privileges being withdrawn, subject to applicable contractual and legal rights.

9. Children and Young People

Where a student is under 18, participation may be subject to parental or guardian consent and applicable safeguarding procedures.

Parents and guardians remain responsible for ensuring that information provided to Gōdō Martial Arts about a child is accurate and up to date.

10. Website Content

All reasonable care is taken to ensure that the information on the Website is presented accurately.

However, the Website is provided for general information and we do not guarantee that it will always be:

- available without interruption;
- free from errors;
- completely up to date; or
- free from viruses or other harmful components.

We may update, amend, suspend or withdraw Website content or functionality without notice where reasonably necessary.
